## ***Section IV- Security & Background***

- Child Abuse History Certification from the Department of Human Services
- If you have had residency outside of the state of PA in the last 10 years (refer to section I), then you will need the Federal Criminal History Report (FBI check)

If you are NOT required to file for the **FBI check**, you will need to complete the ***Disclosure Statement Application for Volunteers*** provided and return it with this form.

By signing **the *Disclosure Statement Application for Volunteers***, you are indicating that:

- a) You have not committed any criminal activity that would prohibit you from volunteering in PA as stated in Title 18 of the Pennsylvania consolidated statutes or under the Child Protective Services Law.
- b) If you are arrested for or convicted of an offense that would constitute grounds for denying participation in a program, activity or service, or is named as a perpetrator in a founded or indicated report, you must provide written notice to the MBIC Executive Pastor no later than 72 hours after the arrest, conviction or notification that you have been listed as a perpetrator in the statewide database.

## ***Section V—MBIC Safety Procedure*** (Check the box if you agree)

- I understand that the safety of our children and students is a priority at MBIC. Any investigation involving child abuse in which a MBIC volunteer might be named a perpetrator, will result in the volunteer being moved into a non-serving status pending completion of the county's investigation.
